With Safari: Click on the top right of the browser (cog-shaped pictogram). Go to Settings, click on Advanced Parameters. In the section "Privacy", click Content settings. In the section "Cookies", you can choose to block them.

With Chrome : Click on the top right of the browser (three lines pictogram). Click Settings. Click Show advanced settings. In the section « Privacy », click preferences. In the thumbnail "Privacy", you can block cookies.

## **9. APPLICABLE LAWS AND JURISDICTION.**
